

CHRISTOPHE MAÉ U.S. CONCERT TOUR

TICKET GIVEAWAY OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR REGULATED.

1. Dates: This Sweepstakes is valid from midnight, April 1, 2018 through midnight, April 15, 2018 (“Sweepstakes Period”).
2. How To Enter: There is one (1) way to enter (all entries are subject to the eligibility requirements of these Official Rules): a) Go to the Christophe MAÉ U.S. Tour TV5MONDE Sweepstakes page on the TV5MONDE USA website (<http://usa.tv5monde.com/en/contest/christophe-mae-us-tourtv5monde-sweepstakes>) and furnish the information requested (“Web Entry”).
3. Eligibility: This Sweepstakes is open only to legal residents of the forty-eight (48) contiguous United States and D.C. (but excluding, without limitation, residents of Puerto Rico and other U.S. territories) who are twenty-one (21) years of age and older at the time of entry. Both the winner of the Sweepstakes and his/her guest must be over twenty-one (21) years of age. Employees, directors and their immediate families (spouse, parents, children, siblings, household members, and each of their spouses regardless where they live) of TV5 USA, Inc. (“Sponsor”), and each of Sponsor’s parent companies, subsidiaries, advertising, design, print production and publicity agencies and anyone connected with the production and distribution of this Sweepstakes (collectively the “Sweepstakes Entities”), are not eligible to enter or be awarded the prize. Residents of any state or other locality in which this offer is prohibited or otherwise restricted are not eligible to participate in these Sweepstakes.
4. Winner Selection: A random drawing will be held on or about April 16, 2018, from among all eligible entries received. Decisions of the judges are final. The potential Prize Winner will be notified by e-mail and/or phone at the discretion of Sponsor on or about April 16, 2018. Odds of winning will depend upon the total number of eligible Entries received.
5. Grand Prize: Six (6) Grand Prizes will be awarded. Grand prize winners will receive 2 tickets to the Christophe MAÉ U.S. concert at their choice of venue in Los Angeles, San Francisco, Houston, New Orleans, New York or Boston on April 25, 2018 – May 4, 2018. Winner must be over 21 years of age in order to qualify to receive the Grand Prize.
6. APPROXIMATE RETAIL VALUE (“ARV”): \$30
7. General Rules: Sweepstakes administration, winner selection and prize claim verification will be conducted by Sponsor. By participating in this Sweepstakes, Prize Winner and any person accompanying him in the use of the Prize agree to be bound by these Official Rules and the decisions of Sponsor, whose decisions are final. All materials submitted become the sole property of Sponsor and will not be returned. Return of any prize/prize notification as undeliverable or a non-working email address will result in disqualification and an alternate will be selected. Sponsor reserves the right to cancel/terminate, modify or suspend the Sweepstakes if in Sponsor’s sole determination it believes that the integrity of the Sweepstakes has been, or could be, compromised or that the Sweepstakes rules have not been complied with, or that the Sweepstakes is not is not is not capable of running as planned or fairly, including, but not limited to, fraud or force majeure or any other causes beyond Sponsor’s control. The right to receive the prize is non-assignable and non-transferable and no prize substitution,

exchange or cash equivalent will be allowed except by Sponsor who reserves the right to substitute the prize (or portion of prize) of equal or greater value in case of unavailability of the prize or force majeure. If any provision of this Sweepstakes shall be deemed to violate any federal, state or municipal law, it shall be amended to conform to such law and all other provisions shall remain in full force and effect. Limitations of Liability: The Sponsor is not responsible for late, lost, damaged, misdirected, incorrectly addressed, stolen, incomplete, illegible, undeliverable, destroyed, or postage-due entries nor for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction nor unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry materials by Sponsor on account of technical problems or traffic congestion on the Internet or at any website or any combination thereof. Any person attempting to damage any website, defraud or in any way tamper with the Sweepstakes will be ineligible for any prize and may be prosecuted to the full extent of the law. The Sponsor shall not be responsible for technical, pictorial, typographical or editorial errors or omissions in any marketing materials or these Official Rules.

Application of California Law, Arbitration: These Official Rules, as well as any dispute between Prize Winner and any person accompanying him in the use of the Prize and Sponsor, and any claim or cause of action brought in connection therewith, shall be governed and construed under the laws of the State of California, without application of its conflict of laws principles. Each entrant, Prize Winner and any person accompanying prize winner in the use of the Prize agrees that any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes or any prizes awarded, and all issues and questions concerning the validity, interpretation and enforceability of these Official Rules shall be resolved individually, without resort to any form of class action, and exclusively by arbitration as provided for in this paragraph. Any claim, dispute or cause of action arising out of or relating to the Contest, the Official Rules, or the participation in the use of the Prize shall be submitted to final and binding arbitration, to be held in Los Angeles County, California, before a single arbitrator, in accordance with California Code of Civil Procedure §§ 1280 et seq. Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes and never shall include consequential, incidental or punitive damages, and in no event
